I / We declare that valid liability insurance will be in effect at all times on each of our motorized vehicles while on Wilderness Village property. This includes cars, trucks or any other type of motorized vehicle.

I / We also acknowledge that legally, I / We are obligated to maintain liability insurance, even if a unit is not being used. Therefore, I / We promise and agree to maintain liability insurance on every motorized vehicle we operate, store or occupy, while it is on Wilderness Village property. I / We understand that in order to utilize the Storage facilities, any member intending to do so must first agree to the condition of holding harmless the Association in the event of any loss or damage.

NOTE: All stored recreation vehicles, including travel trailers, 5<sup>th</sup> wheels, tent trailers, campers, boats, utility & cargo trailers, ATV's (quads, sleds, motorized bikes) must be registered on this form and all be clearly marked with your individual Membership number.
